PRACTICE AREA PROFILE

ohn DeCamillis and Rob Mattingly are well known in Louisville for the success of their litigation practice, one that attracts many referrals from previous clients as well as from other attorneys looking for strong litigators to prosecute personal injury and wrongful death claims. They pride themselves on being a "small firm handling big cases."

The two attorneys, now operating as DeCamillis & Mattingly, PLLC, have worked together since 1999, and have offices located on the busy downtown corner of Third and Market Streets in Louisville. DeCamillis was in practice for about 10 years before he was joined by Mattingly.

to take on the kinds of personal injury and wrongful death cases we handle," Mattingly said. "So we create a co-counsel relationship wherein we take the lead. We litigate cases at our firm's expense and work as co-counsel with the referring attorney. This is a large part of our practice."

"We understand that many attorneys focus their practice on other areas, such as criminal defense, divorce, corporate law, etc.," DeCamillis also noted. "Those attorneys may not feel comfortable taking on the claims we take on."

What clients looking at possible litigation find reassuring about the firm is its extensive trial experience and knowhow. DeCamillis & Mattingly work diligently to bring

several claims a year to trial. For example, a small sampling of trial verdicts recently won by the firm includes judgments in favor of various clients for \$500,000, \$1.075 million and \$5 million. The firm has also handled various civil matters that have resulted in large settlements resolved with confidentiality agreements. Both partners are members of both the Million Dollar Advocacy Forum and the Multi-Million Dollar Advocacy Forum (reserved for attorneys who have achieved verdicts or settlements in excess of \$1 million and \$2 million dollars respectively).

Trying these cases, both large and small, can be "challenging and exhilarating at the same time," according to Mattingly.

"The way our firm is structured," Mattingly said, "John handles the vast majority of the civil cases up to the point of determining if there can be a resolution without filing a lawsuit. If a claim cannot be resolved and needs to go to litigation, then the file is brought up to my desk, and I litigate the claim."




"One of the major challenges of litigation consists of extensive preparation prior to trial: interrogatories, requests for production of documents, handling of depositions and expert discovery as well as the preparation of multi-media technology to present our client's story to the jury," explains Mattingly.

While their strength and experience in themselves give them

an edge in litigation, DeCamillis & Mattingly also stress that they use technologically innovative trial techniques when they face juries.

"We use the most recent cutting-edge technology and innovation in our trials," said DeCamillis, "and have access to TechnoEsq and its software and equipment." This local

"In certain situations when our clients are experiencing financial difficulties, we are pleased to offer our services to help them in their time of need," DeCamillis said. "We have prepared wills, power of attorneys, battled collection agencies and helped to set up corporations for clients needing a little extra help with their current life circumstances."

In addition to their legal practice, DeCamillis & Mattingly also own a property management company through which they purchase downtown Louisville real estate that they are continuously improving and developing. In fact, they own the three-story brick downtown building where their firm is now located.
